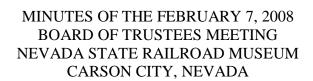


## virginia and truckee división

Call to Order – Meeting was called to order at 6:02 PM

**Role Call** – Present were Bill Kohler, Russ Tanner, Mike Dunn, Jerry Barth, Chris MacMahon, Barry Simcoe, Stan Cronwall, and Kurt Dietrich were present. John Schilling was absent and excused. A quorum was established.

**Minutes** – Kurt Dietrich presented the minutes of the December 13, 2007 meeting to the Board. A motion to accept the Minutes was made by Chris MacMahon, seconded by Jerry Barth. Motion passed.

**Correspondence** – Kurt Dietrich stated that appreciation letters were send to the outgoing Board. Kurt stated that he had also sent a letter to member Charles Dargan concerning By-Laws.

**Sagebrush Headlight** – Frank Ackerman reported that the material deadline for the upcoming publication is in 3 weeks.

**Symposium Committee** – Frank Ackerman reported that he will discuss the Symposium Committee with Bill Kohler. Friends' involvement is expected in March.

## **OLD BUSINESS – SELECT COMMITTEE REPORTS**

**By-Laws Revision Committee** – Russ Tanner reported that the committee will hold a meeting for the general membership on February 23<sup>rd</sup> in the Restoration Shop. The meeting will allow the membership bring issues to the committee's attention. Barry Simcoe proposed the establishment of an Audit Committee, and a Parliamentary Authority Article.

Bill Kohler stated that a Tonopah & Tidewater lantern became available to the NSRM for \$1,600. Barry Simcoe made a motion to purchase the lantern, seconded by Chris MacMahon. Motion passed.

**Upcoming Events –** Bill Kohler stated that the volunteer appreciation night will be held March 14th.

Other New Business - None.

**Board or Trustees Member Comments –** Kurt Dietrich asked the Board if it would be more appropriate to combine the website and promotion & publicity committees. Barry Simcoe recommended against this action.

**General Comments –** Jim Lohse stated that he is willing to sell one of his videos to the Friends through the gift shop at a reduced fee as a membership benefit. Jim requested the Friends to provide stock images for this production.

Russ Tanner stated that Articles of Incorporation are available for Board Members.

Stan Cronwall asked what can be done to mitigate fuel costs. Barry Simcoe stated that he has discussed this issue with Chris DeWitt. Barry stated that fuel mitigation measures should be at discretion of Chris. Bill Kohler suggested that the Board approach oil companies for grants. Ron Allen stated that he will head this campaign.
