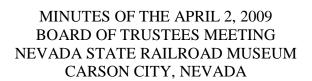


# virginia and truckee division

Call to Order – Meeting was called to order at 6:04 PM

**Role Call** – Present were Bill Kohler, Chris MacMahon, Darlene Berry, Ron Allen, Jerry Barth, Barry Simcoe, Stan Cronwall, and Kurt Dietrich. Absent and excused was John Schilling. A quorum was established.

**Minutes** – Kurt Dietrich presented the minutes of the February 5, 2009 meeting to the Board. A motion to accept the Minutes was made by Ron Allen, seconded by Stan Cronwall. Motion passed.

## **OLD BUSINESS – STANDING COMMITTEE REPORTS**

**Audit Committee** – Bill Kohler stated that he is of the understanding that the books are ready for an audit. Barry Simcoe stated that the 2008 tax return is prepared. Ron Allen stated that he has approached several accountants, and many of them are not accepting new clients. Darlene Berry suggested a CPA, and Ron Allen agreed to make the initial contact.

**Brick Sales Committee** – Lanning Clifford reported that three bricks have been sold. Lanning stated that he had lost his supplier. Brian Sheldon (not present) found a Reno supplier, and recommended that enough bricks be purchased to complete the walk. A discussion took place. Barry Simcoe made a motion to purchase 500 bricks, at \$0.73/brick, and that the executive committee could approve a rate increase, if applicable. Ron Allen seconded the motion. Motion passed.

**Election Committee** – Nancy Humphries presented a cost estimate of \$836.00 for expenses relating to the 2009 election.

Kurt Dietrich suggested exploring the option of an electronic election, such as an online polling, to minimize expenses. Kurt asked Susan Allen how many members currently have an email address of record. Susan stated approximately half of the membership disclosed their email addresses to the Friends. Barry Simcoe stated that the majority of his memberships still use paper ballots. It was agreed by the Board that electronic elections are not appropriate at this time.
