

Call to Order – Meeting was called to order at 6:00 PM.

Minutes – Kurt Dietrich presented the February 2011 minutes. A clarification was made that the \$100 disbursed for the McKeen Car direct mailing was in regards to the ADDY Award fee. A clarification was made that the motion to accept the audit report also authorized the next audit. A motion was made by Stan Cronwall, seconded by Darlene Berry, to accept the minutes as corrected. Ron Allen suggested soliciting the membership. David Brambley, seconded by Chris MacMahon, made a motion to solicit the membership for funds, through a capital campaign. Motion passed.

Darlene Berry, seconded by Kurt Dietrich, made a motion to print fliers for elementary schools, for an amount not-to-exceed \$1,000. Motion passed.

David Brambley, seconded by Chris MacMahon, made a motion to approve the purchase of locomotive bunting for use during Memorial Day and 4th of July weekends, for an amount not-to-exceed \$200. Motion passed.

Chris MacMahon, seconded by David Brambley, made a motion to allow Mark Owens to work on logistics for the Friends to attend the antique show at the Carson Mall, July 15 th, 16 th, & 17th. Motion passed.
