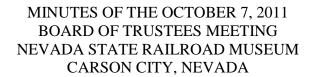

- 7. David Brambley was elected 10/2010 for his 1st 3-year term, which expires 12/2013.
- 8. Ken Allen was elected 10/2011 for his 1st 3-year term, which expires 12/2014.
- 9. Mark Owens was elected 10/2011 for his 1st 3-year term, which expires 12/2014.

Kurt Dietrich must take a required break after serving three 3-year terms. Darlene Berry is leaving the board after each serving one 3-year term.

**Interpretive Committee** – Loren Jahn reported activities that the Interpretive Committee participated in throughout the year. Activities included maintaining the appearance of the running equipment, inviting the Governor to operate V&T No. 25, inviting musicians to perform in the depot, and establishing the V&T in the Movies program.
