

MINUTES OF THE FEBRUARY 9, 2015 BOARD OF TRUSTEES MEETING NEVADA STATE RAILROAD MUSEUM CARSON CITY, NEVADA

Call to order - Meeting was called to order at 6:03 PM

Role Call – Trustees present were Ron Allen, Ken Allen, Larry Knack, Rick Kohler, Kevin Owens, Bill Kohler, Berry Simcoe, Bill Curtis and Matt Digangi. Representing the museum were Greg Corbin, Adam Michalski, and John Walker

Minutes – Minutes of the December 8, 2014 meeting were approved. Motion made by Matt Digangi with second by Ken Allen.

Treasurer's report – Larry Knack reported the period of November 1, 2014 – December 31, 2014.

The treasurer's report was passed unanimously; motion made by Matt Digangi and Seconded by Rick Kohler.

Larry Knack presented a review of annual ongoing expenses for discussion and approval.

Annual payment in the amount of \$13 per membership to the Nevada State Railroad Museum was approved. Motion by Larry Knack, second by Matt Digangi.

Membership Chairman fees based on 15% of regular membership dues was approved. Motion by Kevin Owens, second by Ken Allen.

A decision was reached by the Board to formalize a description of the Membership Chairman's duties and responsibilities.

Discussion was held regarding the continuance of providing Railroad History Magazine to Friends members who are at the \$35 level and above. A decision was reached to discontinue this practice after the existing contract with the publisher has expired. This will happen after two more issues are provided. The decision was reached based on the improvements that are being made to the Sagebrush Headlight and the Board decided that the additional expense of furnishing the Railroad History Magazine was not justified. Motion made by Matt Digangi, second by Ken Allen.

-Steam Train Operations- Barry Simcoe reports that the annual safety meetings are scheduled for April 11 and April 25. On April 11 the steam train will be available for training for those who would like to participate. This will be for members only and no public rides will be offered.

-Sagebrush Headlight- Adam Michalski reports the Sagebrush Headlight has gone through a major change of appearance and should be more appealing. The next issue should be mailed within a week of this meeting. John Hoepfer will investigate what is involved in getting past issues accessible through the Friends website.

-Website - Karen Arendes reports that there has been an improvement in communications she is receiving from the Museum and the Friends and would welcome the Friends setting up cloud storage for their documents.

-Youth Committee - Matt Digangi reported that the possibility of offering a Boy Scout Merit Badge in Railroading is being explored. The Youth Committee would also like to reestablish the handcar participation at local events. John Hoepfer offered to work with the committee to recruit new members.

Other Old Business- Kevin Owens reminded the Board that the minutes from the October, 2014 Board meeting still need to be approved. Bill Kohler will forward these to the board members.

Ron Allen suggested that the Friends motorcar training program be reinstated. There is a person who has paid for a past class but was unable to attend and now would be a good time to schedule a new class. It was decided to schedule a class for September 18, 19 and 20. Russ Tanner, David Squires, Bill Kohler and Larry Knack will participate in organizing and conducting the class.

New Business- Russ Tanner submitted a bylaw change for consideration. The change would formalize the ability to conduct official business by use of the telephone or email. Motion made by Ken Allen, seconded by Matt Digange to review and consider the change.

John Hoepfer proposed that the Friends have T shirts manufactured to sell for National Train Day and for the first public operation of the Glenbrook. He also expressed interest in producing limited edition posters for these events. The Board will consider these suggestions at the next meeting.

Barry Simcoe suggested that a special Board meeting be held to consider items under consideration and to plan future activities. It was decided that this meeting would be held at the museum on Saturday, March 7 at 9AM.

John Hoepfer suggested that the Friends host their own Facebook page that would focus on volunteer activities and would be a draw to attract younger volunteers. The idea will be discussed at the next meeting.

The need for Cloud storage of Friends documents was discussed and will be explored before the next meeting. There is a possibility that the Friends would qualify for a Google Educational account free of charge.
