**Call to order -** Meeting was called to order at 6:46 PM

**Treasurer's report –** See attached report. Motion to approve was made by Ron Allen, second by Dave Squire. Motion passed. Rick Bieniek presented the improved method for handling cash transactions received at the museum. Motion to approve new method was made by Nancy Deis, second by Ron Allen. Motion carried.

Rick Bieniek requested that the Friend approve an amount not to exceed \$2500 for ten cords of firewood. Motion made by Ron Allen, seconded by Bill Barbe. Motion passed.

#### **OLD BUSINESS -**

#### -Audit committee-

#### -Bricks -

Ron Allen will be the go between person with the brick engraver and the Friends. Dan Thielen suggested that, due to delay in the installation of the bricks, the Friends take the brick order and turn over the bricks to museum staff to complete the installation. A motion was passed to coordinate brick purchases with museum staff. Motion made by Michael McClain, second by Dave Squire. Ron Allen abstained from the vote.

#### -Events Committee -

Rebecca Bevans reported that Warren Engine Company will participate on Saturday and Sunday during the Labor Day steam up with Hot Rodz food truck handling Monday.

#### -Rail Camp-

Bill Kohler reported the Rail Camp was an unqualified success. There was a last minute cancellation that could not be back filled so it was decided to refund half of the cost per published policy. One of the rail camp participants has reserved for next year and will be charged this year's price to participate.

Discussion was held to increase the price of the camp. It was decided that as a result in the current pricing of the camp being significantly less that comparable activities being held by other organizations the price should be increased. A motion was made by Ron Allen, second by Rebecca Bevans that the cost to attend be raised to \$1495. Motion passed.

Further discussion was held regarding pricing that resulted in rescinding the previous motion. Motion to rescind made by Ron Allen, second by Rebecca Bevans. Motion passed.

A motion was made by Nancy Deis to increase the price of the camp to \$1995, seconded by Dave Squire. Motion passed.

Michael McClain said he will update the website to reflect the new cost.

## Fund Raising –

Bill Barbe asked that a donation method be set up to accept Lyon donations during the Great Western Steam Up. Dan Thielen reported that he is working on a donation system that would include much of the participating equipment.

Todd Moore reported that he has completed the necessary paperwork to accept grant donations from Travel Nevada and Visit Carson City.

#### V&T 150/Rail Fair Committee -

Todd Moore reported that about 1700 tickets have been sold so far, the Friday and Saturday being the busiest. The event website is being updated to reflect operating and activity changes.

Todd presented the sponsorship agreement between the Friends and the museum regarding the event. Motion was made to accept the agreement by Rebecca Bevans, seconded by Rick Bieniek. Motion passed.

Rick Bieniek reported that the tables and chairs for the banquet will be delivered on the Friday before the banquet. He expressed a need for carpet runners to be purchase to cover the rails in the shop for safety reasons. A motion was made by Nancy Deis, seconded by Bill Barbe to spend not to exceed \$850 for runners. Motion passed.

Adam Michalski reported that volunteer spots are being filled nicely and additional sources for volunteers are being explored. There will be volunteer orientation meetings held on June 26, 27 and 30.

Barry Simcoe reported that the campaign is taking a break while focus is on the Great Western Steam Up.

Since April 31<sup>st</sup>, our total assets decreased \$10,035.07 from \$149,732.44, to a total of \$139,697.37, which was due to a onetime charge of \$30,000.00 for advertizing costs for the GWSU (magazines/TV/etc). Sales for the GWSU for the same period still remained strong at \$29,378.43 for the month of May. We also received a \$2,500.00 sponsorship for the dinner from VTRRHS. Our general checking account grew by \$2,627.97 to \$59.239.06, and the GWSU account decreased by \$12,663.31 to \$32,501.37. And, we gained \$0.27 of interest in our Money Market Account. There was no change in the Resteam Account for this period

I also included the Etix summary of sales between Feb 1<sup>st</sup>-Jun 1<sup>st</sup>, hopefully I ran the report correctly.

We also received our first payment from Amazon Smile of \$257.19!! Thanks to Ron Allen for getting this fixed.

I also redesigned our Blue Membership Form to include sequence numbers in 2 places, the main form and the customers receipt. The new form if approved will be printed on 8 ½ x 11 paper. This form and the new log sheets to track the forms and the instructions are included. Upcoming expenses, the springs for the Lyon were ordered in April and when completed, the last payment of \$4,542.50 will be due from the Resteam account. See you all at the Board Meeting! RickB

#### Cash Handling Procedures for FNSRM

#### Problem:

In our latest audit report from 2021, it was identified by our auditor that FNSRM has a 'significant deficiency' on how we handle cash transactions. Even though we only handle a small amount of cash, it was decided by the Audit Committee and the April Board Meeting, to put in place a set of procedures to mitigate this issue.

#### Solution:

The Audit Committee decided to add sequence numbers on the blue forms we use for all membership applications and for all donations.

#### Procedures:

- The <u>sequenced</u> blue forms will only be kept in the museum gift shop in the store room and at the Depot.
- When a cash, check or credit card transaction takes place (membership or donation), the volunteer/clerk, will:
  - o Check the log sheet to see what the next sequence number is.
  - o Go the store room and verify the next sequence number and take only that form.
  - Have the customer fill out their information.
  - The volunteer/clerk will accept the form and the cash, sign it, and date it. They will then detach the receipt and give it to the customer.
  - The volunteer/clerk will enter the date, form number, the amount, and their name into the log sheet.
  - The volunteer/clerk will then attach the cash to the form with a paper clip and, place the form and cash into the US Bank pouch.
- If a mistake is made on the form and a new form is required, then:
  - The volunteer/clerk will write 'VOID' on the form.
  - Enter the information into the log sheet and check the Void box.
  - Put the voided form in the US Bank pouch and restart this procedure.

#### For Cash Transactions received via Mail at the Museum:

- The volunteer will open the mail at the museum and check the log book for the next sequence number and get that form.
- They will fill in the information on the Membership form, sign and date the form.
- They will then fill in the information in the log book.
- Attach the cash to the form and place that form in the US Bank pouch.
- They will do this for each cash transaction.
- The Treasurer or a designated person will pick the pouch up at the end of the month, verify the amount in the log book and the pouch, if they match, then they will deposit the cash.
- The deposit receipt will be forwarded to the Treasurer and verify it against the log sheet.

#### GREAT WESTERN STEAM UP MASTER SPONSORSHIP AGREEMENT

THIS GREAT WESTERN STEAM UP MASTER SPONSORSHIP	P AGREEMENT (the
"Agreement") is made as of the day of	(the "Effective Date"), by and
between the STATE OF NEVADA, ACTING BY AND THROUGH THE	NEVADA STATE RAILROAD
MUSEUM, CARSON CITY, AN INSTITUTION OF THE DIVISION OF N	JUSEUMS AND HISTORY
("Museum"), and the FRIENDS OF THE NEVADA STATE RAILROAD	MUSEUM, THE VIRGINIA &
TRUCKEE DIVISION, a Nevada non-profit corporation ("Sponsor")	).

The Nevada State Railroad Museum is holding the Great Western Steam Up at the Nevada State Railroad Museum in Carson City, Nevada on July 1-4, 2022, to celebrate the 150<sup>th</sup> anniversary of the completion of the Virginia & Truckee Railroad and increase visitation and awareness of Museum among the general public (the "Event").

WHEREAS, Sponsor desires to provide administrative and financial contributions to support Museum in producing and conducting the Event.

NOW, THEREFORE, the parties hereto hereby agree as follows:

- 1. <u>Sponsor Commitment</u>. Sponsor shall provide administrative and financial sponsorship to Museum as follows:
  - 1.1 Market and sell tickets and sponsorships relating to the Event.
- 1.2 Collect and receive ticket and sponsorship revenues, which are to be deposited into a segregated account maintained solely for purposes of Sponsor's activities directly related to the Event.
- 1.3 Expend ticket and sponsorship revenue pertaining to the Event solely for the purposes of promoting and conducting the Event, including but not limited to Event advertising, professional event coordination, public relations, Event infrastructure, fuel for locomotives participating in the Event, transportation costs relating to the Event and shuttles to take guests to and from the Event. Any expenditure of Event sponsorship or ticketing revenue shall subject to the prior approval of the Director of Museum;
- 1.4 Use certain names, designs, logos, marks, colors, phrases, scripts and other information (the "Marks") owned by the Museum to promote the Event and to contract with providers of advertising, provided such use has been approved in advance by the Director of Museum.
- 1.5 All ticket sales and sponsorship revenue obtained by Sponsor relating to the Event and net of the expenditures described above shall be paid the Museum as directed by its Director.
- 2. <u>Museum Commitment</u>. Museum shall permit Sponsor to sell memberships in Sponsor's organization through its Event promotional and ticket sales

activities and shall permit Sponsor to sell water at the Event and keep all revenues of said sales.

- 3. <u>Publicity</u>. Sponsor shall use reasonable efforts to publicize the Event from time-to-time. Sponsor has expended the sum of \$30,000 from its own funds toward promotion of the Event.
- 4. <u>Term.</u> This Agreement is effective retroactive to January 1, 2022 (the Effective Date) and shall end on August 5, 2022, unless sooner terminated in accordance with the terms hereof ("Term").
- 5. Records. During the Term, Sponsor shall keep and maintain accurate records of all transactions of Sponsor involving its use of ticket and sponsorship revenues relating to the Event. Sponsor shall make said records available to the Director of Museum at any reasonable time for inspection and copying upon a prior minimum notice of two (2) business days.
- 6. <u>Ownership</u>. All Events and activities of the Museum are properties of the Museum and it hereby reserves all rights relating thereto.
- 7. <u>Indemnification</u>. Museum shall indemnify, defend and hold harmless Sponsor from and against any and all claims, liabilities, damages, costs and expenses, including attorneys' fees, resulting from the activities of the Museum.
- 8. <u>Termination</u>. Each party shall have the right to terminate this Agreement at any time upon the occurrence of the following:
- 8.1 Either party to this Agreement fails to observe or perform any of its material obligations under this Agreement, where such failure continues for a period of ten (10) days after written notice thereof from the other party hereto;
- 8.2 Either party engages in conduct that, in the reasonable opinion of the other, is materially detrimental to the public image of the other, as determined by the damaged party in its reasonable discretion, where such conduct continues for a period of ten (10) days after written notice thereof from the damaged party; or
- 8.3 Museum determines, in its sole discretion, to cancel the Event, in which event, the Museum and Sponsor agree to mutually negotiate the terms upon which revenues and expenditures relating to the Event shall be apportioned between them.
- 9. <u>Relationship of Parties</u>. Notwithstanding anything contained herein to the contrary, the relationship between the Museum, on the one hand, and Sponsor, on the other hand, shall not be deemed to be a partnership, joint venture or agency. Neither party shall have any right or power to bind or obligate in any manner the other.
- 10. <u>Assignability</u>. Sponsor shall not, either voluntarily or by operation of law, assign its rights to, or delegate its responsibilities under this Agreement without the prior written consent of Museum, which consent may be withheld in the Museum Director's reasonable discretion.

- 11. <u>Cooperation</u>. The parties hereto shall, in good faith, cooperate with each other and, from time-to-time, execute and deliver such further instruments as any party or its counsel may reasonably request to effectuate the intent of this Agreement.
- 12. <u>Use of Marks</u>. # Motorcar report for FNSRM board meeting June 13, 2022

On April 6<sup>th</sup> Cary Ingbar, Dan Osborne and Mike Shaughnessy did some training on the Edwards car.

On April 9<sup>th</sup> Nancy Deis, Aaron and Gideon Vickers did some training on the Edwards car.

On April 16<sup>th</sup> and 17<sup>th</sup>, the McKeen car ran for Easter weekend. The Edwards car *did not run for lack of crew*. It was nice weather and very busy.

May 3rd, I fueled and lubed the 401. I bought a grease gun for the Edwards. May  $6^{th}$  was a tour for 30+ home schoolers.

There was a Dueling Doodlebugs event for Mother's Day weekend on May 7<sup>th</sup> and 8<sup>th</sup>. It was cold and snowed.

May 20th was another school tour for 40 students.

There was scheduled Edwards operations on May 21<sup>st</sup> and 22<sup>nd</sup>. The "Flag Stop" operation was introduced and was well received. We used the Friends wheel-barrow for this operation. The wheelbarrow was kindly donated by Richard Gorbet. We even had a visit from the farmer's wife.

There was a tour by 100+ students and staff on May 26<sup>th</sup>. Cary Ingbar, Bill Barbe and Gary O'Leary stayed afterwards and washed the exterior of the McKeen car.

It is getting difficult to schedule crew for the motorcars. We have not had a motorcar class since 2015 and I would like to schedule some classes later this year. I will be preparing a proposal for the class (i.e., cost, curriculum, etc.) which will be presented shortly. I also plan to have motorcar certification with practical testing. This will be real world testing somewhat like getting a driver's license. Passing will be identified by some sort of indication on the museum name badges.

As part of the upcoming Great WesternSteam Up, the Nevada and California State

Railroad Museums came to a historic agreement which will bring Virginia & Truckee Railroad
locomotives No. 12 *Genoa* and No. 21 *J.W. Bowker* to Carson City and No. 18 *Dayton* and the
former Central Pacific Commissioners Car/V&T Coach 17 to Sacramento for two years. This
loan will greatly expand the interpretive opportunities for both museums and will help to
assemble the largest group of V&T locomotives since the 1930s this summer for the Great
Western Steam Up. Additionally, the loan furthers the working relationship between the Nevada
and California State Railroad Museums and helps each museum's collection reach a wider
audience. Staff of both museums felt that bringing locomotives that worked in Nevada back to
the state afforded them the greatest interpretive potential and enabled two artifacts built in
Sacramento to be interpreted and displayed where they were built. Overall, this loan brings two
museums with similar collections and interpretive goals closer together, broadens their reach,
and brings five Civil War era railroad artifacts back to locations integral to their histories.

*Genoa* was built by the Baldwin Locomotive Works in 1873 as the Virginia and Truckee Railroad's backup express passenger engine and numbered 12. The locomotive was considered the fastest on the V&T and was used in rotation with No. 11 *Reno* and No. 22 *Inyo* on the daily express train for most of its career, but also hauled local "accomodation" mixed trains. *Genoa* was the first V&T engine to be fitted with air brakes in 1874, a major safety improvement for the road. The locomotive continued to be used in regular passenger service as the favors of the railroad ebbed and flowed until it was leased to the Sierra Nevada Wood and Lumber Company in 1900 as a placeholder for their number 3, the former *J.W. Bowker*, while it was being overhauled. In 1902, No.12 was extensively overhauled by the V&T and appeared from the shop as it does now, with a distinctly more modern appearance. The locomotive was used regularly on

the daily mixed train on the railroad's Minden branch until October of 1908 when it was again overhauled. However, the railroad no longer needed No.12 and stored it until 1938. The Eastern Railroad Presidents Conference bought No. 12 in 1938 and repainted it as Central Pacific *Jupiter* for the 1939 World's Fair. In 1940, the locomotive was donated to the Railway and Locomotive Historical Society, who operated the engine at the 1948 Chicago Railroad Fair and in a plethora of excursions and public appearances throughout Northern California and Nevada before donating the locomotive to the state of California in 1969. From 1979-1981 the California State Railroad Museum restored No. 12 to its 1902 appearance.

Hosting the *Genoa* gives the museum an opportunity to interpret and display how the V&T modernized their passenger engines over time to have a more modern appearance. The *Inyo* currently serves to show how passenger locomotives appeared in the 1880s and the *Lyon* and *Glenbrook* are examples of the fancy paint schemes of the 1870s, but the museum has not had an example of a modernized Civil War era locomotive until now. The addition of No. 12 will provide an example of how the Carson shop crews were able to keep locomotives from the 1870s operating into the 1910s and beyond. The locomotive's simple black paint scheme, chipped off builders date, 9.5" air-pump, sunflower stack, and knuckle couplers all tell the story of how the *Genoa* remained in service for over 30 years.

J.W. Bowker was built by Baldwin in 1875 for the V&T as their Virginia City and Gold Hill switching and firefighting engine. It spent most of its time on the railroad switching ore cars and flat cars loaded with lumber and cord wood for the mines of the Comstock Lode. The locomotive also came with a Knowles steam water pump between the boiler domes and fought the frequent fires started by the railroad's fleet of wood-burners. The locomotive was named after the railroad's master mechanic, who was infamously fired for drunkenness not even four

months after the new engine arrived, prompting the engine to be renamed *Mexico* until about 1879. The V&T sold No. 21 in 1896 to Sierra Nevada Wood and Lumber Company, where the locomotive became number 3 and worked until the mid 1910s. In 1937, the engine was donated to the Railway and Locomotive Historical Society, who used the engine for movie and tv appearances, as well as special excursions and displays. In 1969, *J.W. Bowker* was donated to the State of California and became part of the California State Railroad Museum's collection.

Adding the *J.W. Bowker* to the museum's interpretive scope will finally enable the interpretation of the V&T's switching and fire fighting engines. While it is true that both the *Lyon* and *Inyo* spent time as dedicated switch engines, they were not purpose built for switching like the *Bowker*. The locomotive's compact 2-4-0 design was uniquely suited to switching cars loaded with cordwood and timbers or strings of ore cars around Virginia City and Gold Hill. The Knowles steam water pump is especially unique and will enable the museum to explore the railroad's role in starting and fighting fires during the steam era and the subsequent environmental effects of both fires and logging. Additionally, the *Bowker* is painted as it would have appeared in the 1890s, expanding the range of decades represented by locomotives at the museum.

In exchange for the *Genoa* and *J.W. Bowker*, the museum is sending *Dayton* and the former Central Pacific Commissioners Car/V&T Coach 17 to the California State Railroad Museum. Both artifacts were built by the Central Pacific in their Sacramento shops and have never been displayed in that city. Much like how bringing No. 12 and 21 to Nevada enhances their interpretive value by being in proximity to where they operated, having No. 18 and Coach 17 in Sacramento enhances their interpretive value by being almost exactly at the spot of their construction. Thanks to this loan, *Dayton* will be in Sacramento for its 150th birthday and the

Genoa and J.W. Bowker will be in Carson City for the 150th anniversaries of their delivery to the V&T.

This loan would not have been possible without the dedicated staff of both the Nevada and California State Railroad Museums, as well as several passionate volunteers. Thanks to their efforts, the greatest gathering of Virginia and Truckee locomotives since the 1930s will happen at this summer's Great Western Steam Up. *Genoa* and *J.W. Bowker* are scheduled to arrive in Carson City within the next two weeks and will be visible to the public once reassembled. Make sure to come to the Great Western Steam Up and see these two extraordinary locomotives in person and appreciate their eclectic histories.
